OBJECTION ON DELIMITATION OF PROVINCIAL ASSEMBLY PS- 22, SUKKUR-I,  
P.S 23 SUKKUR-II, P.S 24 SUKKUR-III AND P.S25 SUKKUR -IV OF SUKKUR

That the applicant respectfully submits his objections on the newly delimitation on the seats of the Provincial Assembly P.S 22- Sukkur-1, Provincial Assembly P.S 25- Sukkur-IV, as under;-

That applicant is registered voter of the NA-206 SUKKUR-1, as well as P.S 22- Sukkur -1, bearing Vote No; 73, Block Code No; 324010101, and has cast his vote in the Deh pano Akil Taluka Pano Akil District Sukkur.

That applicant being the possessing the political thoughts and has also care to serve for his local person by this way he is willing to contest the elections.

That applicant also willing and careful for up coming elections for SUKKUR constituency PS- 22- Sukkur -1 and P.S 25 Sukkur-IV.

That as now election commission has made the delimitation without looking at the facility and care of voters as well as candidates and has also made such delimitation which creates the difficulties to candidates to reach at his voters at their house as well as to show them what is the importance of his vote what change can be brought by casting his vote to eligible person and voters has been kept away to see who is better for his who is eligible for his vote.

That due to adding and excluding the areas from city to an other by this way the right are going to be deprived of voters and areas are suffering due to away from the approach of the person who have been succeeded from tier consistencies.

That my proposal is this that Tappo Hingor and Tappo Sadhuja may kindly be excluded from the P.S 25 Sukkur-IV and same may kindly be added to P.-22 Sukkur-1 as these areas are near by the P.S 22- Sukkur I taluka Pano Akil.

That the areas of Tappo Sadhuja and Tappo Shahapur may kindly be excluded from the P.S-22 Sukkur -1 and may kindly be added to P.S 25-Sukkur-IV, for

the welfare of voters as well as for the welfare of area as they may easily can approach to the person who however succeed from their constituency.

That the main proposal of the applicant is this that for the welfare of voters, areas of P.S 22- Sukkur-1, the areas of Sadhuja and Tappo Shahpur may kindly be excluded from P.S 22 Sukkur-I. as they are far away and near to P.S 22- Sukkur-I and must be added to P.S 25 Sukkur-IV.

It is also proposal that from the P.S 25 Sukkur-IV area Deh Hingoro and Deh nauraja may kindly be added to P.S 22-Sukkur-1 and same may kindly be added to P.S-22 Sukkur-1.

That now the delimitation has been made and mostly changes has been made on which applicant objects being voters and might be candidate and applicant feels for his voters present delimitation creates the problems if this election commission will look at delimitation of previous status of the Provincial Assembly seats.

That it is also my proposal regarding the P.S-22 Sukkur-1, as applicant has already prayed for adding Tappo Hingoro and Tappo Nauraja New may be excluded fro P.S 25 Sukkur –IV and added in P.S -22 Sukkur-I.

That so area Tappo Sadhuja and Tappo Shahpur as these areas are near by to the P.S-25 Sukkur IV so they may be added in P.S 25 Sukkur-IV, and excluded from P.S 22 Sukkur-1 by this way voters as well as candidates will get facility to cost their vote as well as candidate will be easily to approach to their voters.

That my proposal may kindly be accepted just in the interest of voters as well as for the welfare to solve the necessary problem of the voters.
