- I am Voter and Resident of Deh/Tapa Madd Aleem Taluka Bhiria, District Nausharo feroze.
- II. That PS-35 NAUSHARO FEROZE III as per preliminary proposal's publication is 429980 and is perhaps the longest distance among the four constituencies of District Nausharo Feroze touching the boundary of District Nawabshah and District Khairpur in the south and compactness and

homogeneity as well as population factors are not favourable. Under the humble proposals given by the undersigned objector, it is proposed that Tapedar Circle MADD ALLEM population 27659 of BHIRA Taluka maybe deducted/taken out of PS-35 NAUSHORO FEROZE III and added to adjoining KANDIARO Taulka viz constituency no PS-33 NAUSHAHRO FEROZE –I. Population of preliminary proposals of PS-33 Noshahro feroze-I is 392795. By addition of Tapa MADD ALEEM of Bhiria Taulka, the population of PS-33 NAUSHARO FEROZE-I will rise from 392795 to 420454 and Population of other above said constituency PS-35 Nausaro feroze III of primarily proposals of 429980 will come down to 402321. In this small change 3 major principles of election laws will be accommodated.

- a) Compactness will be improved and major towns of Kandiaro and Tharushah for commercial, agricultural and educational purposes will be more homogenous for the society of this and adjoining areas.
- b) The long distance of over 45 kilometres of PS-35 Naushahro Feroze III will be minimised for the candidates and other parties and for general public to approach their representative more easily.

c) Compactness will be much improved between PS-33 and PS-35 Naushahro Feroze I and III respectively.

d) Length of the constituency will be reduced from the border of Kandiaro in the north to the end of the taulka Nausharo Feroze in the south and difference of population between PS-33 and PS-35 Naushahro feroze will be minimised from the population 37185 to 18133. That the population difference shall also be generally acceptable on the principle of equal population in the district between the constituencies as far as possible.

This request is made in the interest of Justice.

It is therefore requested that the above given objections of the undersigned may be considered accordingly.
