Subject: (1) OBJECTION ON INCLUSION OF TAPO KHAKHAR HALA IN PS-79 (EX-PS 85) MIRPUR SAKRO OF DISTRICT THATTA-III AND (2) RESTORATION OF TAPO KHAKHAR HALA IN PS-77 (EX-PS 84) THATTA-I.

Respected Sir,

We, the undersigned/applicants, belonging and representing to different communities, residing in different Dehs (Sub Tapo) of Tapo (Tapedar Circle) Khakhar Hala of Tehsil & District Thatta, through our authorized person Mohammad Hanif s/o Abdul Majeed, respectfully submit as under:

FACTS

1. That, under the geographical location, our said Tapo (Tapedar Circle) Khakhar Hala is closed to Tehsil Head Quarter Thatta (about at the distance of 2 kilometers) as such it is well convenient to all voters to approach different offices situated at Tehsil headquarters and too during elections.
2. That, under present and revised delimitation by the Election Commission, our said Tapo has been excluded from the constituency of Tehsil Thatta (now PS 77 Thatta-1) and has been included in Tehsil Mirpur Sakro (PS 79 of Thatta-III) which Tehsil headquarters is far away from us at more than 50 kilometers.
3. That, we observe the above change by Election Commission of Pakistan contravene the very spirit of the 24th constitutional amendment attempting to equate the delimitation

process to void the disparity in the population criteria but unfortunately the disparity still exists in our case on the following grounds:

GROUND

1. The constituency of PS-77 Thatta-I (Tehsil Thatta) has total registered votes as 3,12,348 whereas the constituency of PS-70 Thatta-III (Tehsil Mirpur Sakro) has registered voters as 3,41,412. Accordingly PS-77 has as much as 29,064 votes less than PS-79 which fact hits the principle of equality and essence of 24th Constitutional amendment.

2. That, if Tapedar Circle (Tapo) Khakhar Hala having present registered votes is restored in PS-77 Thatta-I, almost both constituencies shall have equal proportion of registered votes in district Thatta.

PRAYER

In the light of above facts, circumstances and grounds, it is prayed that Tapedar Circle (Tapo) Khakhar Hala may be excluded from PS-79 (Mirpur Sakro Thatta-III) and restored in PS-77 Thatta-I, in order to defeat the disparity and for convenience of thousands of registered voters of Tapo Khakhar Hala.

The application is made in the wider interest of justice.
