OBJECTIONS ON THE CONSTITUENCIES OF PS-93 KORANGI-II & PS-92 KORANGI-I

1. Sub Division Model Colony should be made a single constituency ie PS-93 Korangi-II which has total population 383,801. It would be better for public convenience and geographical compactness too.
2. Census Charge No.9 of Model Colony Sub-Divison added in PS-92 Korangi Karachi-I could have been added in PS-93 Korangi Karachi-II which includes all Census Charges of Model Colony Sub-division as it does fulfill geographical compactness. The authorities have not taken into consideration the following section 20 of Election Act 2017, before delimiting the above mentioned constituencies, which reads;

20. Principles of delimitation.—(1) All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public

convenience and other cognate factors to ensure homogeneity in the creation of constituencies.

3. Census Circle No.3 of Charge 1 of Sub-division Shah Faisal is adjacent to the PS-92 of ECP Form 5 and should be included in PS-92 Korangi-I.
