Respected Sir:

With your kind respect I undersigned as being a voter of my constituency PS-01 (Ex. PS-14) the legal objection has been submitted by me as accord with Draft constituency of Election Commission of Pakistan for the District Jacobabad. As per Draft constituency Tapedar circle Zangipur excluded from PS-01 and included to PS-03 which is not matched with geographical and population facts of view. Therefore you are requested to submit my proposed constituency for above subjected matter and approved my request for the submitted memorandum.

The Objection has been raised due to following Geographical and population point of view fir PS-01, PS-02 and PS-03.

A. Geographical Point of View

- The Tapedar circle Balochabad and Tapedar circle Mubarakpur situated along with Begari canal by different link road (As defined in proposed constituencies Map) and other side Tapedar circle Abad is directly connected with these two Tapedar circle Balochabad and Mubarakpur via Abad -Mubarpur -Thul road and Tapedar circle Abad remained constituency of PS-03 already.
- 2. The circle Mubarakpur is connected with circle Balochabad via Abad town in PS-3 (As per new constituencies by Election Commission) where as circle Zangi Pur is connected with Jaccobabad city via Thul Jaccobabad Road is PS-01 (As per proposed Map)
- 3. The Municipal committee of Jacobabad is nearby with Tapedar circle of Zangipur, Bahadupur and Kareembux via Main Jacobabad and Thul road which is situated and constituency in PS-01 by Geographical facts and figures.

- 4. As comparison of proposed constituency Map and new constituency map by Election Commission the following GAP has found
 - i. As per new constituency Map by Election Commission PS-03 (As Tapedar circle Zangipur included) comes in between PS-01 and PS-02 which is not matched as per Geographical facts.
 - ii. As per our proposed constituency Map PS-01 is connected with PS-02 which is geographically found right and matched (see proposed Map)
 - iii. As per new proposed constituency Map PS-02 connected with PS-03 via Abad-Mubarakpur-Thul road which is matched with Geographical facts.

B. POPULATION POINT OF VIEW

- 1. The population of Tapedar circle of Zangipur (Population 18,538) and the population of Tapedar circle of Mubarakpur (18,557) are approximately same.
- 2. As per new proposed map if Tapedar circle of Mubarakpur than this will not effect on population of both constituency of PS-01 and PS-03 which are remained same on both side PS.
- 3. If population of PS-03 (Population 323,643 less than PS-02) need to be increased than including of Tapedar circle of Mubarkpur and constituency of PS-02 (Population 346,083 greater than PS-03) can be included to adjust the both side population.
