Subject: OBJECTIONS ON THE DELIMITATIONS OF PS-113, DISTRICT WEST-KARACHI:

Respected Sir,

1. SELF INTRODUCTION

With due reverence, It is submitted that I am the resident and voter of PS-113 District West Karachi. I am also sitting MPA from this constituency.

2. OBJECTION

It is submitted that Charge 03 Sub-Division Harbour District West-Karachi has been excluded from PS-113 and the same was included in PS-112.

GROUNDS OF OBJECTION

- A. Population of Charge No. 03 which is comprises of islands called Baba Island, Bhit Island, Shamspir Island, Salehabad Island, Kaka Village Island, Younasbad Island, Katchi Line and Manora Cantonment.
- B. Due to the exclusion of Charge No. 03 from PS-113 this constituency i.e. PS-113 has been fragmented into two parts (highlighted in the map with yellow colour).
- C. The population living in these islands have culturally, historically and geographically attached with the PS-113.
- D. Major parts of Charge No. 03 are under the administration of Jackson Police Station and Docks Police Station of Harbor Sub-division i.e. PS-113.
- E. Most of the population attached with fishing profession, where Karachi Fishery is also located in the same constituency i.e. PS-113.
- F. The whole population acquires services of schooling, hospitalizations, local purchasing etc. from Keamari i.e. PS-113.
- G. The travelling distance of these islands via Keamari Jetty is 10 to 15 minutes to the City via proper Jetties. However, it is approx. 02 hours at distance from PS-112 and there is no facility of jetty also.

H. It is important to mention here that the utility facilities as like of drinkable water line which is lying under the sea is passing through PS-113 (Keamari).

3. SUGGESTIONS

- A. The population of Charge No. 03 and Manora Cantt is 36,109.
- B. It is requested that this Charge i.e. Charge No. 03 be included in PS- 113.
- C. Charge No. 01 Circle No. 1,2,3 and 5 population is composed of 35,954.
- D. It is requested that these Circles of Charge No. 01 be excluded from PS-113 and included in PS-112.
- E. It is also mentioned that Charge 01 Circle 1,2,3 and 5 is geographically attached with PS-112.
- F. In this way the net population of PS-113 would become 367,591. Similarly, the net population of PS-112 would be 356,128.
- G. Sir, it is pertinent to mention here that the existing net population of PS- 113 is 367,436 and the present net population of PS-112 is 356,283.

PRAY

Therefore, it is respectfully prayed that this honorable Commission may be pleased to allow the instant application and accept my pray in the better interest of the residence of the both constituencies.
