ELECTION ACT 2017 READ WITH RULE 12 OF THE ELECTION
RULES 2017 AGAINST THE PROPOSED DELIMITATION OF
PROVINCIAL ASSEMBLY CONSTITUENCY PS-19 GHOTKI-II,
PS-20 GHOTKI-III DISTRICT GHOTKI FOR THE REASONS
BELOW.

Respectfully Sheweth:

1. That the petitioner is a registered voter of the proposed constituency of PS-19 Ghotki-II, of District Ghotki.
2. That the proposed constituency of PS-19 Ghotki-II and PS-20 Gotki-III consist of 426263 & 402266 voters respectively.
3. That according to the preliminary report regarding PS-19 Ghotki-II and PS-20 Gotki-III of District Gothki is hereunder:-

4. That according to the draft proposal for delimitation of constituencies there are no variation in population between the constituencies. It is basic principle of delimitation that all the seats shall, as far as practicable delimited having regard to the distribution of population in Geographically compact areas, physical feature, existing boundaries of administrative unit, facilities of communication and public convenience and other cogent factor to ensure homogeneity in the creation of constituencies.

 6. *That if the any change regarding said constituencies are being made petitioner will face irreparable loss.*
