
3. That being aggrieved and dissatisfied with the above said preliminary list of delimitation of constituencies dated 05.03.2018, the petitioner preferred representation, legal objections, inter-alia, on the following grounds: -

GROUNDS

a. That the petitioner is registered voter of Deh Rajo
Dahri Tehsil Mehrabpur District Naushahro Feroze
as such entitled to make representation to raise
objections for alteration and modification in
preliminary proposals of delimitation of Provincial
constituencies.

- b. That the petitioner has been contested the local council elections of Union Council Lakha Road Taluka Mehrabpur District Naushahro Feroze and succeeded to elected as Vice Chairman of Union Council Lakha Road Taluka Mehrabpur District Naushahro Feroze, Sindh.
 - c. That preliminary proposal of delimitation for provincial assembly seats in District Naushahro Feroze has been issued while violating the geographic features, existing physical areas, compact boundaries of administrative units, facilities of communication, public convenience and other cognate factors to ensure homogeneity in the creation of constituencies in District Naushahro Feroze as enumerated in Section 20 of the Elections Act 2017 and Rules 7,8,9 and 10 of the Elections Rules 2017.
 - d. That the delimitation committee has proposed the constituencies for Provincial Assembly of Sindh in District Naushahro Feroze keeping aside the guidelines given in the Act and rules.



- e. That in the preliminary list of constituencies there has been gross violation of sub section 1 of section 20 of the Election Act 2017 by not considering the existing boundaries of administrative unit in tact, which requires to keep the existing boundaries of administration unit in tact as far as practicable. The boundaries of administrative units have not been divided conveniently without applying the principles as laid down in the Act 2017 and Rules. While of delimitation preliminary list of constituencies, the delimitation committee disturbed the existing constituencies and ignored the public interest to approach the central part of their respective cities, health units/hospitals, Courts, communications and interaction with themselves and others and also to approach their representative resulting in great inconvenience and hardship to the public at large.
 - f. That if the preliminary list of constituencies of the above said District are not set-aside, modified and amended the public at locality as well as at large would suffer an irreparable loss.

- g. That according to preliminary list of provincial constituencies the actual facts at grounds are not considered the District has been divided in a zig-zag manners instead of clock-wise pattern. Without centralizing each constituency, far-flung areas have been included, instead of adjacent areas. Moreover, disturbance has been created to approach the National Highway and other communications to the local people as the people would have to travel through different Talukas to enter into different parts of same constituency. The inclusion of entire Taluka Mehrabpur and some parts of Taluka Kandiaro in the same constituency would be suitable on account of business, social communication, to access main part of Taluka Mehrabpur and to get common facilities. In addition the approach of students to school and colleges of same constituencies would also be distrubed.
 - h. That exclusion of Taluka Bhiria is liable to be excluded from Taluka Mehrabpur because it has no attachment with the communications of Taluka Mehrabpur. It has better communication, administration, geographic attachment with

Naushahro Feroze and Moro instead of with Mehrabpur.

- i. That the petitioner is submitting proposals after serving the ground realities and taken into consideration all the relevant factors as envisaged under Section 20 of the Election Act, 2017 and rules.
- j. That the marked map of the provincial constituencies of District Naushahro Feroze are attached.
- k. That other grounds would be addressed with the permission of this Honourable Commission at the time of arguments.
