DELIMITATION OF CONSTITUENCIES OF PS-37 SHAHEED
BENAZIRABAD-I, PS-38 SHAHEED BENAZIRABAD-II, PS-39
SHAHEED BENAZIRABAD-III & PS-40 SHAHEED BENAZIRABAD-
IV UNDER THE ELECTION ACT, 2017 AND ELECTION RULES,
2017.**

With due respects it is submitted that I am resident of village Mehrabpur Taluka Sakrand District Shaheed Benazirabad. I am registered as a voter at the above address under serial No. 52 in Block code 346010716.

2. That being a voter of the area I am interested to exercise my vote to such a candidate who works for the betterment of the general public of the area, therefore, the limits of Constituencies are in my mind which may be in the benefit of the voters.

3. That the Election Commission of Pakistan notified the Draft List of Constituencies on Form-5 under Rule 10(7) of above Rules on 5th March, 2017 for inviting representations / suggestions.

4. That I alongwith other voters of the area have gone through the Draft List of Constituencies of District Shaheed Benazirabad and found that the said list has been prepared by the Election Commission of Pakistan in accordance with law, Rules and the Delimitation Committee has followed the principles of Delimitation looking to and considering the ground realities and public convenience and other cognate factors as laid down in Section 20 of the Act *ibid*.
5. That the above mentioned objector namely Syed Zain-ul-Abdin has proposed that TC Marri Sabbar of Jam Sahab STC of Taluka Daur may be excluded from Constituency No. PS-39 Shaheed Benazirabad-III and instead TC Meer Muhammad Juno of STC Qazi Ahmed of Taluka Qazi Ahmed may be included in the said Constituency.
6. That the Objector above named has further proposed that TC Marri Sabbar may be included in PS-37 Shaheed Benazirabad-I.
7. That the above said TC Marri Sabbar is quite in contiguity with the other areas which have been shown in the Draft List of Constituencies in respect of PS-39 Shaheed Benazirabad-III and its inclusion in PS-37 will be against the public convenience as the people of that area do not want such change.

8. That the constituency map earmarked by the Election Commission is quite clear that the above said area is very much contiguous and connected by means of communication and other public convenience where it has been included by the Election Commission of Pakistan.

9. That any change in the Draft List of Constituencies would not be feasible in the interest of voters and the Draft List may be finally published.
