**BEFORE THE ELECTION COMMISSION OF PAKISTAN**

**REPRESENTATION IN RESPECT OF THE DELIMITATION OF THE  
CONSTITUENCY PS-56 PROPOSED IN THE PRELIMINARY REPORT**

Respectfully Sheweth:

1. That the objector is a registered voter of Constituency No. PS-61 (old) who is aggrieved by the delimitation of this constituency proposed in the preliminary report. In order to substantiate this fact his copy of ID Card is attached with this Memorandum.
2. That it is the Constitutional obligation of the Election Commission of Pakistan to ensure free and fair polls in the country. For achieving this objective fair and transparent delimitation is indispensable. Election Commission of Pakistan is duty bound to provide all voters of the constituency such an environment or process where they can exercise their right to vote in a free and convenient manner.
3. That the preliminary report relating to delimitation suggests that demarcation of the boundaries of electoral constituency No. PS-56 is faulty and may disenfranchise a great number of voters on the following grounds:
  - a. Voters of this constituency had been exercising their right of votes without any difficulty in the elections which were held in the year of 2002, 2008 and 2013 because facilities of communication were easily available, therefore, there is no legal justification for disturbing the demarcation of boundaries of this constituency for the upcoming

elections as the population is approximately the same for newly created and previous constituency.

- b. Previously this constituency was numbered as PS-61 (old) which is PS-56 now. The population of PS-61 (old) was 405456 whereas the population of PS-56 is 406192. If the demarcation of boundaries of constituency number PS-61 (old) is kept intact it will not cause any hindrance in conducting the elections in an honest, just, fair and free from corrupt practices manner.
- c. The District Election Commissioner Tharparker who conducted the physical survey of all the constituencies in Tharparker District proposed and recommended that the demarcation of boundaries for electoral constituencies which were made previously and elections in the years of 2002, 2008 and 2013 were held according to that demarcation should remain the same for the upcoming elections as well. Therefore, changing of the boundaries of electoral constituencies of this district may cause unnecessary problems to the voters who are familiar and know where the polling stations are, and to which constituency they belong.
- d. The vital component of PS-61 (old) Mithi which is a District Headquarter and belong to Single Municipal Committee of the District but in the proposed delimitation the same has been detached and in the way identification of Mithi may be diminished. Therefore, the original boundaries of this electoral constituency be remains the same.

- e. That, Town Chachro, TC Chachro, TC kantio & TC Hanjital of Taluka Chachro be excluded from PS- 56 & included in PS- 54, TC Rajoro of Taluka Chachro & TC Sengaro of Taluka Islamkot be excluded from PS- 55 and be included in PS- 56. TC Manjhthi, TC Bapohar and TC Jhun be excluded from Ps-56 and be included in PS-57. MC Mithi, TC Mithi TC Joruo, TC Posarko be excluded from PS-57 and be included in PS-56.
- f. There is a communication problem for the people in the new de limitation as TC chachro was included in PS-56 which is 65 KM away from Islamkot which is a Town Committee.
- g. While proposing the delimitation for PS-56 the authorities have entirely ignored ground realities relating to communication system which is unjustified.

Under the circumstances, it is respectfully prayed that the proposed demarcation of electoral constituency No. Ps-56 is illegal, unjust and without lawful authority be set aside and status of old constituency as it existed prior to issuance of proposed report may kindly be restored tin the interest of justice, equity and fair play.
