REPRESENTATION IN PURSUANCE OF RULE 12(1) OF ELECTION RULE 2017 AGAINST THE DRAFT PROPOSALS PUBLISHED BY ELECTION COMMISSION OF PAKISTAN IN RESPECT OF DELIMITATION OF CONSTITUENCIES OF PROVINCIAL ASSEMBLY SEATS SINDH BEARING NO. PS-60 TANDO ALLAHYAR-I & PS-61 TANDO ALLAHYAR-II, DISTRICT TANDO ALLAHYAR, HYDERABAD DIVISION, SINDH.

It is respectfully submitted that being the registered voters of Deh Gujjo and Deh Aamri, Tapedar Circle Tando Allahyar, Taluka and District Tando Allahyar and disagreed and aggrieved by the preliminary draft proposals published by the Election Commission of Pakistan, we the undersigned hereby make representations/objections with the prayers that above Constituency PS-60 (old 51) may be re-delimited on consideration of following facts and grounds.

1. That our Dehs Aamri and Gujjo are part of Tapedar Circle, Tando Allahyar which are located in between Municipal Committee Tando Allahyar and Town Committee Nasarpur, Taluka Tando Allahyar whose boundaries are touching the Municipal Committee Tando Allahyar and Town Committee Nasarpur. Since Municipal Committee Tando Allahyar and Town Committee Nasarpur have been included in delimitation of PS-60, but our dehs are included in PS-61 despite the fact that our means of communication, trade business as well as educational and health facilities are being got from both Municipal Committee and Town Committee, Nasarpur. Hence, the applicants and the people of these dehs will seriously be prejudiced and affected if these dehs are not included in PS-60. The population of above Tapa Tando Allahyar Circle is as under:

2. That by inclusion of above dehs with Tapedar Circle Tando Allahyar, the applicants and the people of its vicinity will be benefitted and the mandatory principle of law as settled within the ambit of Section 20 of Election Act 2017 will also be complied with.
3. That Deh Aamri and Deh Ghab of above Tapedar Circle Tando Allahyar were already part of PS-51 (now PS-60). Hence, the same requires to be kept in the same old position in the interest of justice and the public at large.




4. That due to above position, the applicants and the people of that area will be affected in terms of facilities of communications and public conveyances as Municipal Committee Tando Allahyar is headquarter of District Tando Allahyar where health, educational and other facilities are available. The applicant being very close to Municipal Committee will be deprived of above facilities and also there shall be question of distribution of population in geographically compactness, physical features, existing boundaries of administrative units and also homogeneity in creation of above Constituencies. If above dehs are not included in PS-60.
5. That after inclusion of above Tapa Tando Allahyar, the population of PS-60 will increase above 10 percent, for which the Tapas namely Jhando Mari, Additional Jhando Mari, Halepotani and Additional Halepotani of of STC Jhando Mari, Taluka Jhando Mari may be excluded from PS-60 and be included in PS-61, by doing this, STC Jhando Mari will completely go in PS-61 to ensure homogeneity and geographical compactness of area. Copy of proposal along with map are enclosed at **(Annexure-A&B respectively)**
6. That the above request of applicants is fully justified and based on proper reasons. The Election Commission is competent to make the proper delimitation in the interest of Government and the public as prayed below.

It is, therefore, requested that above Tapedar Circle Tando Allahyar may be included in PS-60 and Tapas namely Jhando Mari Additional Jhando Mar, Halepotani and Additional Halepotani of Taluka Jhando Mari (Total Population is 40242) may be excluded from PS-60 and be included in PS-61 . By doing this, the population of both constituencies will not exceed above 10 percent and there will be no violation of Rule 12 of ibid rules. The request is made in the interest of Justice and the public as well.


