REPRESENTATION IN PURSUANCE OF RULE 12(1) OF THE **AGAINST RULES** 2017 PROPOSALS PUBLISHED BY ELECTION COMMISSION OF PAKISTAN IN RESPECT OF DELIMITATION CONSTITUENCIES OF PROVINCIAL ASSEMBLY SEATS <u>SINDH BEARING NO. PS-60 TANDO ALLAHYAR-I & 61</u> <u>TANDO ALLAHYAR-II, DISTRICT TANDO ALLAHYAR,</u> HYDERABAD DIVISION, SINDH.

It is respectfully, submitted that being the registered voters of Municipal Committee, Tando Allahyar, Provincial Assembly Constituency of PS-60 (old PS-51) and disagreed and aggrieved by the preliminary draft proposals published by the Election Commission of Pakistan, we the undersigned hereby make representations/objections with the prayers that above Constituency PS-60 (old 51) may be re-delimited on consideration of following facts and grounds as below:-

- 1. That as per instructions contained in Sub-Rule 04 of Rule 10 of ibid rules, in case of urban areas, the census circle shall not be broken in any circumstances. However, in above delimitation of PS-60, census circle of Municipal Committee, Tando Allahyar has been broken, whereby, five census blocks bearing No. 363010101 - 363010105, total population thereof viz-5,121 of Municipal Committee have been included in PS-61 (old PS-52) and shown as Tando Allahyar Rural. These five census blocks of Municipal Committee requires to be included in PS-60 as Municipal Committee is already included in new delimitation PS-60.
- 2. That due to broken of census circle area, the boundaries of Municipal Committee are being affected and the Constituency of PS-60 is going to become in two parts. Map enclosed at (Annexure-A).
- 3. That during release of initial census results by Census Department for Census 2017, an error was made whereby above five census blocks of Municipal Committee Tando Allahyar have been included in Tando Allahyar rural. Such mistake was pointed out to them by Deputy Commissioner,

Tando Allahyar. In reply thereof, the Pakistan Bureau of Statistics, Government of Sindh vide letter dated 01-02-2018 has realized the fact and informed that above census blocks 363010101-05 will be included in Municipal Committee at the time of releasing final statistics. Copy of letter No. 01-02-2018 of Deputy Census Commissioner (G) is enclosed. (Annexure-B).

- 4. That before rectification of above error, Election Commission has made delimitation on the basis of old data of Census Department, the same error has also been made in making delimitation of above Constituencies which requires to be rectified by the Election Commission.
- 5. That originally Tapedar Circle Tando Allahyar comprised the dehs namely Tando Allahyar, Aamri, and Ghab and was already included in old PS-51 but during delimitation of Local Government in 2015, a part comprising of five census blocks of Deh Tando Allahyar was excluded from Tapedar Circle Tando Allahyar and included in Municipal Committee Tando Allahyar but in release of initial results, above error was made. However, the remaining one Census block (363010106, population 781) was included in Deh Tando Allahyar Rural. Therefore, entire Tapedar Circle Tando Allahyar comprising of above Deh is very close and its boundaries touch the Municipal Committee but the Dehs of above Tapedar Circle have now been excluded from PS-60 (old PS-51) and included in PS-61 (old PS-52) which requires to be included in PS-60 (old PS-51) in pursuance of the principles of delimitation as contained in Section 20 of the Election Act 2017, as Municipal Committee was already part of PS-51 (now PS-60) and under current delimitation, it is in the intact position. Copy of above referred provisos of act and rule 2017 is attached as (Annexure-C)
- 6. That due to above position, the applicants and the people of that areas will be affected in terms of facilities of communications and public conveyances as Municipal Committee Tando Allahyar is headquarter of District Tando Allahyar where health, educational and other facilities are

The applicant being very close to Municipal Committee will be deprived of above facilities and also there shall be question of distribution of population in geographically compactness, physical features, existing boundaries of administrative units and also homogeneity in creation of above Constituencies as contained in Section 20 of ibid Act.

- 7. That after inclusion of above five blocks and Tapa Tando Allahyar whose population comes 39,251, the population of PS-60 will increase above 12 percent, for which the Tapas namely Jhando Mari, Additional Jhando Mari, Halepotani and Additional HAlepotani of Taluka Jhando Mari (total population 40,242) may be excluded from PS-60 and be included in PS-61, by doing this, STC Jhando Mari will completely go in PS-61 to ensure homogeneity and geographical compactness of area. Copy of proposal enclosed at (Annexure-D).
- 8. That the above request of applicants is fully justified and based on proper reasons. The Election Commission is competent to make the proper delimitation in the interest of Government and the public in accordance with the settled principles as per Election Laws as prayed below.
- 9. That further averment will be made at the time of arguments and hearing as and when conducted by Election Commission.

It is, therefore, requested that above five census blocks along with Tapedar Circle Tando Allahyar may be included in PS-60 and Tapas namely Jhando Mari, Additional Jhando Mari, Halepotani and Additional HAlepotani of Taluka Jhando Mari (total population 40,242) may be excluded from PS-60 and be included in PS-61, By doing this, the population of both constituencies will not exceed above 10 percent and there will be no violation of Election Laws. The request is made in the interest of Justice and the public as well.
