**GROUND FOR PROPOSED COMPOSITION OF PS-60,
TANDO ALLAHYAR-I**

1. That the notified composition for Provincial Assembly constituency (PS) hit the Principles of Delimitation, section 20, chapter III, election act 2017, as per principles the existing boundaries of administrative units are far away from each other which cause inconvenience to the people of the area. Adjusting district boundaries can have major consequences on electoral process.
2. That from North to South periodically Taluka Jhando Mari comes first in district, so there is no need to break Taluka Jhando Mari as population criteria does not effect on other constituency. It is further submitted that by unnecessarily break the composition of Taluka Jhando Mari which may cause inconvenience to the people of the area and against the principles of administrative units, so it may be pleased to reconsider and intact the Taluka Jhando Mari in original position.
3. That the following composition may also facilitate the people of the area, facilities of communication and ensure homogeneity in the creation of constituency.
