It is respectfully submitted that being the registered voters of Deh Saajna, Deh Halepotani, Deh Langhano and Deh Ghaado, STC Jhando Mari and Taluka Jhando Mari, District Tando Allahyar and disagreed and aggrieved by the preliminary draft proposals published by the Election Commission of Pakistan, we the undersigned hereby make representations/objections with the prayers that above Constituency PS-61 (old 52) may be re-delimited on consideration of following facts and grounds as below:-

1. That our Deh Saajna, Deh Halepotani, Deh Langhano and Deh Ghaado, STC Jhando Mari and Taluka Jhando Mari, District Tando Allahyar (population 40,242) which were mostly part of PS-52 (now PS-61) but we have now been included in PS-60 (old PS-51) which required to be kept in same position viz PS-61.
2. That by inclusion of above dehs in PS-60, the applicants and the people of that area will seriously be affected as this area pertains to Rural and there are various communities of different castes who are having their social contacts, relations and business with the people of PS-61 and the various communities have chronic conflicts with the other communities in PS-60. Therefore above Dehs may be continued to retain in PS-61 so that no such issue/difficulty may arise during election.
3. That further averment will be made at the time of arguments and hearing as and when conducted by Election Commission.
4. That after inclusion of above STC Jhando Mari, the population of PS-61 will exceed above 10 percent, for which some areas of

PS-61 may be excluded from PS-61 and be included in PS-60, by doing this, STC Jhando Mari will completely retain in PS-61 to ensure homogeneity and geographical compactness of area. Copy of proposal and Map are enclosed at **(Annexure-A & B)**.

It is, therefore, requested that above STC Jhando Mari of Taluka Jhando Mari, District Tando Allahyar may be excluded from PS-60 and be included in PS-61. By doing this, the people of that area will not face problems and the population of both constituencies will not exceed above 10 percent and there will be no violation of Election Commission Laws. The request is made in the interest of Justice and the public as well.


