**OBJECTION ON DELIMITATION OF P.S. 66 AND P.S 67. HYDERABAD.**

The applicant respectfully begs to submit as under: -

1. That Applicant is residing at above given address with his family members
2. That the area where he is living is situated within the limits of PS.66
3. That the population of Hyderabad Taluka city is about 755000 (Seven Lac Fifty Five Thousands) which is divided into two P.S. 66 and P.S. 67 from which P.S. 66 is well developed and rich in resources and P.S. 67 is non developed and poor in resources and situated with katchi abadies and on backward areas out of reach of development programs
4. That the areas of P.S 66 are Cantonment, Hirabad Kalhora Colony, Doctors Colony, Saddar Hyderabad, Resham Gali , Shahi Bazar, Tilk Incline, Tando Wali Muhammad, Siri Ghatt, Hyder Chowk, Chotki Ghutti which are rich areas of Hyderabad and of P.S. 66
5. That in P.S. 67 area are Madina Town, Aliabad, Lalo Lashari, Phuleli, Preatabad, Noorani Basti which are backward and non-developed areas and out of reach of basic development works
6. That our request is that some of the charges of P.S. 66 may kindly be shifted to P.S. 67 and some of developed charges may kindly be shifted to P.S. 66
7. That through this Act: This city will develop equally and right of both P.S. will be in favour of equality and Justice
8. That charge No. 1,2,17 and 18 are under union councils No. 1,2,3,4,5 and are in Deh Gujjo from which charge 17 and 18 are given to P.S. 66 and 2 charges 1 and 2 are given to PS. 67
9. That due to divide of Deh Gujjo People of this locality will face problems

10. That it will be in favour of peoples of this constituency, if charges of 16, 17,18,19 will be given to P.S: 67 and charges of 10,11,12,13 and 14 will be given to P.S. 66 which was previously parts of P.S 66. These areas are near to the constituency of P.S. 66


