
Dear Sir,

- 1. That the objector/petitioner is voter of proposed PS-7 and Member of Provincial Assembly Sindh from PS-11 proposed PS-07 Shikarpur-I elected in General Election 2013 and then also won byelection held in October 2016.
- 2. That after the new census conducted in 2016-17, the Hon'ble Election commission of Pakistan empowered under Election Act, 2017 ordered for fresh delimitations of National as well as Provincial Assemblies constituencies in whole of the country.
- 3. That the Hon'ble Election Commission of Pakistan on 03.03.2018 notified the preliminary/proposed list of delimitation of National as well as Provincial list of constituencies and invited objections over it within one month.
- 4. That the undersigned is concerned about the delimitation carried in District Shikarpur for Provincial Assembly constituencies. The relevant facts of District Shikar pur for the purposes of the delimitation are as under;

- 5. That the district Shikarpur is divided into three provincial assembly constituencies no. as PS-07 Shikarpur-I, PS-08 Shikarpur-II and PS-09 Shikarpur-III as the minimum threshold in the province of Sindh for Provincial assembly constituency is of population 369,000/- approximately.
- 6. That the Hon'ble Commission issued the preliminary delimitation reports of these three provincial constituencies which are as follows;

7. That the said preliminary delimitation were carried but petitioner/objector has objection on the following

GROUNDS/OBJECTIONS

- A. That the delimitation of district Shikarpur has not been carried out in accordance with the principle and guide-lines provided in section 20 of the Election Act which is as follows;
 - **20.** "Principles of delimitation.—(1) All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of population in geographically compact areas, physical features, existing boundaries of

units facilities of communication and

administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies."

- B. That the petitioner has its grievance of including of only one patwar circles or Tapu i.e the Udha which is administrative part and parcel of Garhi Yasin having its population of 11,474 is made part of proposed PS-07 which should be part of PS-09 including with Taluka/ tehsil Garhi Yasin. The people of the said Tapu, Udha will be deprived from choosing its representative from the area for which they historically, administratively connected hence the inclusion of tapu Udha is illegal and it may be part and parcel of the Taluka Garhi Yasin.
- C. That the other ground for proposal of inclusion of Tapu. Udha into PS-09 is that PS-09 has fewer voters in number i. e **393,819** as compared to other two constituencies of the district hence for homogeneous distribution of population which may not be ignored while doing delimitation of the constituencies. Hence by including the Tapu Udha into PS-09 which is otherwise connected to Taluka Grahi Yasin the population of PS-09 will be Approx **405,293**. The said no. of ppopulation will create balance of population in district Shikar Pur.

The Proposed Map is also annexed with this Objection Petition.

- D. That the Grahi Yasin i.e PS-09 has some key offices of tulaka in the tapu Udha i.e the city Police station and its jurisdiction over the tapu Udha so its disconnection with the PS-09 constituency will deprive the voters of Udha which for all theadministrative purposes are attached with the taluka Garhi Yasin PS-09.
- E. That applicants have no objection on the area is PS-8 it may kindly be confirmed as same proposed by the Election Commission of Pakistan.


