PETITION OF OBJECTIONS

The petitioners, above-named, most respectfully and very humbly submit as under:-

That the petitioner # 1 is the resident of PS-90 and his 1. address mentioned in the title of the petition, so he is directly aggrieved by the new Delimitation of the Election by the announced Constituencies as Commission.

- 2. That the petitioner # 2 is the resident of PS-90 and his address mentioned in the title of the petition, so he is directly aggrieved by the new Delimitation of the Constituencies as announced by the Election Commission.
- 3. That the Delimitation Act provides delimitation of constituencies in accordance with nature of distribution of population in geographically compact areas and the same is provided under Section-9 and for ready reference, the same is reproduced as under:-
 - "[9. Principles of delimitation.—All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of population in geographically compact areas, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies.

Provided that for the purpose of delimiting constituencies for the general seats for the Federal Administered Tribal Areas two or more separate areas may be grouped into one constituency.

- (2) As far as may be the constituencies for election to the same Assembly shall be equal among themselves in population.]"
- 4. That the Delimitation of the Constituencies as proposed by the Election Commission in respect of PS-90 and 91 which shows that the same are not in accordance

with the provisions of Section-9 i.e. geographically not compact and for one part of the constituencies as in the case of 90 & 91, we have to go through the area of other constituencies and neither the same are homogenous because some urban area has been included in the PS with rural area whereas other adjacent urban area have been included in other constituency, which means that the constituencies are neither compact nor homogenous.

5. That further the boundaries of the administrative units have been divided in such a way that not to provide facilities of communication and public convenience and in the present proposal, one part of the constituency is situated separately from other part of the constituency i.e. the part of PS-90 is practically situated within the limits of PS-91. It is to be noted that boundaries of the said area which was included in PS-90 does not touch the PS from any side but covered from four sides by the constituency of PS-91, so it is against the directives provided by the Act of 1974. Therefore, the petitioners have framed proposals and annexed with this petition.

6. That PS-90 is also another example of non-compactness as charge # 5 of Ibrahim Hydri Sub-Division exist as Island as covered by the area of PS-91.

In view of the above, it is therefore prayed that draft proposals/ objections shall be considered and the Delimitation of the Constituencies shall be re-checked and re-defined as per proposals made by the petitioners.
