- 1. That the petitioner is a social and political activist. Many times he contested election in his constituency, particularly in the local election and secured good position through constituency.

That due to 2017-18 delimitation conducted by Hon'able Election Commission of Pakistan the constituency has been changed and renumbered and now constituency of the petitioner is PK 64 and previously it was PK 12 KPK having total population of 291316. According to Petitioner's proposal all the adjacent PC with naturally and geographically connected PC having its total population 290770 validly constitute PK 64 would be implemented (Copy of Propose Site Plan explaining view point of petitioner is attached as annexure B and proposed delimitation population for PK 64 is attached as B/1)

Similarly petitioner invites the kind attentions of this Honorable Election Commission of Pakistan towards the 2nd proposed delimitation for PK 64 consisting of following Patwar Circle of Tehsil Pabbi having total population 290309 as explained in a proposed plane No.2 attached as annexure "C", with corresponding Population Description as annexure "C-1")
