CORRIGENDUM

Islamabad, 9th September, 2015.

No.F.4(8)/2015-LGE(P):— In partial modification of this Commission's Notification of even number dated 27th August, 2015, containing appointments of **Appellate Authorities** for disposal of appeals against the decisions of the Returning Officers rejecting or accepting the Nomination Papers filed by the candidates in Union Councils/Wards for elections to the direct seats of Local Governments in the districts of the Punjab Province, and in pursuance of sub-rule (10) of Rule 14 of the Punjab Local Governments (Conduct of Elections) Rules, 2013, Election Commission of Pakistan hereby amends the aforesaid Notification as follows:
