## NOTIFICATION

No.F.4(2)/2015-LGE(P)(Vol-IV):— In partial modification of this Commission's Notification No.F.4(2)/2015-LGE(P) dated 3<sup>rd</sup> March, 2015 and in exercise of the powers conferred under section 3A of the Delimitation of Constituencies Act, 1974 read with sub-section (2) of Section 8 of the Punjab Local Government Act, 2013, Rule 11 of the Delimitation of Constituencies Rules, 2015 and all other powers enabling it in that behalf, Election Commission of Pakistan hereby alters the dates for the activities mentioned at Sr. No.1 to Sr. No.4 and appoints the following new dates for those activities due to some administrative reasons:

3	Filing of Representations and Objections before the Delimitation Authority	8 <sup>th</sup> June, 2015 to 22 <sup>nd</sup> June, 2015
4	Disposal of Representations and Objections by the Delimitation Authorities	23 <sup>rd</sup> June, 2015 to 7 <sup>th</sup> July, 2015
