## NOTIFICATION



No.F.6(3)/2015-LGE(S):— In partial modification of this Commission's Notification of even number dated 9<sup>th</sup> July, 2015, and in exercise of the powers conferred under section 3A of the Delimitation of Constituencies Act, 1974 read with sub-section (2) of Section 10 of the Sindh Local Government Act, 2013, Rule 11 of the Delimitation of Constituencies Rules, 2015 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby alters the dates for the various activities and appoints the following new date for those activities due to some administrative reasons:
