## NOTIFICATION

Islamabad, 9<sup>th</sup> April, 2015

No.F.8(1)/2015-LGE(C)(Vol-IV).— Pursuant to the termination of election proceedings of Ward No.1 of Cantonment Board Peshawar by the Returning Officer and in exercise of the powers conferred upon it under sub-section (1) of Section 58 of the Cantonments (Amendment) Ordinance, 2015 read with Rules 8, 14 & 22 of the Cantonments Local Government (Election) Rules, 2015 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby issues the following Schedule for Election to fill the general seat in **Ward No.1 of Cantonment Board Peshawar** and calls upon the electors of the ward to elect their representative from the above referred ward:

**Note:** *The Returning Officer and Appellate Authority etc. previously appointed vide ECP's Notifications No.F.8(3)/2015-LGE(C) dated 16.03.2015 and No.F.8(4)/2015-LGE(C) dated 03.04.2015 shall continue to perform their duty in accordance with the above referred schedule.*

- ii. *All the letters/instructions issued by ECP previously for Cantonments Elections-2015, shall be strictly observed for the election to Ward No.1 of Peshawar Cantt.*
- iii. *It shall not be necessary for validly nominated candidate who have already filed their Nomination Papers, to file fresh Nomination Papers or make deposit under sub-rule (6) of Rule 17 of the Cantonments Local Government (Election) Rules, 2015.*

2. With a view to ensure that election to the Cantonment Board is conducted honestly, justly, fairly and in accordance with law and to ensure that the corrupt practices are guarded against, the Election Commission of Pakistan directs that:

- (i) *All Executive Authorities in the Federation and in the Provinces shall not use State Resources in Election to the Cantonment Board calculated to influence the elections in favour of a particular candidate.*
- (ii) *If any person in Government Service misuses his official position in any manner in order to influence results of the elections, he shall be liable to be proceeded against under Section 86 of the Cantonments Ordinance, 2002;*
- (iii) *No transfers/postings of the civil servants appointed by Election Commission for conduct of Cantonment Boards Elections shall be made after the issuance of Election Schedule without prior approval of the Commission till the publication of election results;*
- (iv) *After the issuance of Election Schedule, the Prime Minister, Governors, Chief Ministers, Chairman Senate, Deputy Chairman Senate, Speakers of Assemblies, Deputy Speakers of Assemblies, Federal and Provincial Ministers, Advisors to the Prime Minister or Chief Ministers or any other holder of public office will not visit the area of any Cantonment Board to announce any development package or to canvass or campaign for any candidate or any political party.*
- (v) *Any holder of public office, who is found to have violated any provision of the applicable Election Law or the instructions issued by the Election Commission, shall be proceeded against as mandated in law.*

**Note:** *The concerned offices of the Election Commission as well as the offices of Returning Officers shall remain open on all public holidays during the schedule period.*

*All electoral activities mentioned in the aforesaid schedule except for those for which time is fixed in the Rules, shall be undertaken during office hours (08:00 A.M. to 04:00 P.M.) and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.*
