
## NOTIFICATION

Islamabad, 20<sup>th</sup> March, 2015

No.F.8(3)/2015-LGE(C).— In pursuance of the provisions of Article 218(3) of the Constitution of the Islamic Republic of Pakistan read with sub-section (5) of Section 58 of the Cantonments Ordinance, 2002 and Rule 12 of the Cantonment Local Government (Election) Rules, 2015, the Election Commission hereby authorizes the Returning Officers appointed for the conduct of Local Government Elections in Cantonment Boards, scheduled to be held on **25.04.2015** to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) with immediate effect till the announcement of official results.

2. The aforesaid officers shall exercise the powers of Magistrate First Class in respect of the offences punishable under Section 77, Section 78, Section 79 and Section 80 of the Cantonments Ordinance, 2002. These offences shall be tried in a summary way in accordance with the provisions of the Code of Criminal Procedure, 1898 (Act No. V of 1898) in terms of Section 86 of the Cantonments Ordinance, 2002.
