Islamabad, the 6<sup>th</sup> October, 2015


No.F.27 (1)/2015-LGE-KPK (Vol-II):-WHEREAS, under Rule-70 (6) of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules 2014, the Returning Officers, appointed for the conduct of Election to the seats of Nazims & Naib Nazims in the District/ Tehsil/Town Councils in Khyber Pakhtunkhwa have declared the names of the members commanding the confidence of the total majority of members of the Local Council concerned.

WHEREAS, under 2nd proviso of rule 21 *ibid*, Nazim and Naib Nazim of the Village Council or Neighbourhood Council have been elected by the Council itself.
