## ELECTION COMMISSION OF PAKISTAN NOTIFICATION

## Islamabad the 18th August, 2015

No.F.23(1)/2015-LGE-KPK.- WHEREAS, sub-section (2) of Section 79 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule 66 & 71 of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules ,2014 provide that a local council shall in its first meeting and to the exclusion of any other business elect from its members a Nazim and Naib Nazim by open division.

AND WHEREAS, under Rule 66 ibid , the District Returning Officers have nominated the Returning Officers to preside over the first meeting of the Council concern for the election to the seat Nazim and Naib Nazim in the District/City District /Town/Tehsil Counicl of Khyber Pakhtunkwa Province.

AND WHEREAS, second proviso of sub-rule (1) of Rule 21 ibid provides that in case of uncontested election to the general seats in a Village Council or, as the case may be, a Neighbourhood Council, the Nazim and Naib- Nazim of the said Council shall be elected by the Council itself.

AND WHEREAS, proviso of section 27 ibid provides that if required number of village Council or Neighourhood Council have been elected unopposed, the election of Nazim and Naib Nazim of village Council or Neighourhood Council, as the case may be, shall be conducted in the manner as provided in section 79 ibid.

NOW THEREFORE, in exercise of powers conferred under Section 75 and Section 86 ibid and all other powers enabling it in that behalf, the Election Commission hereby appoints the following Officers as Returning Officers for election to the seats of Nazim and Naib Nazim of District/Tehsil/Town/Neighbourhood /Village Councils of Khyber Pakhtunkhwa:
