## NOTIFICATION

Islamabad, the 15<sup>th</sup> July, 2015.

No.F.16(1)/2015-LGE-KPK ( Vol-II) :— In exercise of the powers conferred upon it under Article 219 (d) of the Constitution of Pakistan , sub-section (1) of section 75 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with sub-rule(10A) of rule 42 of the Khyber Pakhtunkhwa Local Councils ( Conduct of Elections) Rules 2014 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby notifies the schedule **to fill the reserved seats in Tehsil/Town Council and District Council of the Province Khyber Pakhtunkhwa which remained vacant due to non-filing of nomination papers by the candidates of respective political parties or exhaustion of the priority lists of candidates** of those political parties who secured more seats than the priority lists of candidates earlier provided to Returning Officers and in connection therewith appoints the following dates of determination of qualification of prospective candidates of the such political parties:

(d)	Last date for filing of <b>Appeals</b> against decisions of the Returning Officers accepting / rejecting the nomination papers	28.07.2015
(e)	Last for deciding appeals by the Tribunal	30.07.2015
(f)	Last date for <b>Withdrawal</b> of candidature	31.07.2015
(g)	Publication of <b>revised list</b> of candidates	01.08.2015
(h)	Declaration of results by the Returning Officer on	02.08.2015

2. The authorized persons of those political parties whose priority list of candidates is exhausted shall submit additional names of candidates under rule 42 (10A) **on or before the filing of nomination papers by the candidates i.e 22.07.2015** or in


case ,none of the candidate of such political parties has submitted nomination papers earlier but political party has secured number of general seats in District and Tehsil /Town Councils, they **shall also submit nomination papers** to the concerned Returning Officer in District and Tehsil Councils to fill those vacant reserved seats..

3. The Appellate Authorities appointed vide this Commission's notification No.F.13(1)/2015-LGE-KPK dated the 29<sup>th</sup> April ,2015 shall be the same to hear and decide appeals .

4. All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hour (08:00 a.m. to 04:00 pm) and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.

**Note:** The offices of the Election Commission as well as the offices of Appellate Authorities, District Returning Officers and Returning Officers shall remain open on all public holidays during the schedule period.
