

ELECTION COMMISSION OF PAKISTAN

NOTIFICATION

Islamabad, the 11th December, 2015.

No.F.6(16)/2015-LGE (S):— Pursuant to the Order dated 18.11.2015 passed by the Hon`ble Supreme Court of Pakistan in CMA No. 7996/2015 filed by the Election Commission of Pakistan against the order dated 17.11.2015 passed by High Court of Sindh , Karachi in CP Nos. D-6358, 6898, 6906, 6899, 6900, 6901, 6902, 6903, 6904, 6905, 6370, 6688, 6689 and 6690 of 2015 and in exercise of the powers conferred upon it under Article 140(A) of the Constitution of Islamic Republic of Pakistan, sub-section (1) of Section 34 of the Sindh Local Government Act, 2013 read with sub-rule (1) of Rule 12 (1) and Rule 21 of the Sindh Local Councils (Election) Rules 2015 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby issues Schedule for the constituencies annexed relating to direct elections in Sindh Province and calls upon the electors of those constituencies/seats of local councils where proceedings of Local Government Elections were terminated by the Returning Officers concerned under Rule 21 *ibid* or pursuant to Orders of the Hon`ble Courts referred to above , to elect their representatives and specifies in relation thereto , the following dates:

2. With a view to ensure that elections to the Local Government are conducted in accordance with the provisions of Articles 218(3) of the Constitution, the Election Commission of Pakistan directs that:

- a. All Executive Authorities in the Federation and in the Provinces shall not use State Resources in Local Government bye-Elections calculated to influence the elections in favour of a particular candidate or a political party.

- b. If any person in government service misuses his official position in any manner in order to influence results of elections, he shall be liable to
- c. be proceeded against under Section 67 of the Sindh Local Government Act, 2013.
- d. No transfers / postings of the civil servants shall be made after the issuance of Schedule of local government elections without prior approval of the Commission till the publication of election results.
- e. After the issuance of Election Schedule, the Prime Minister, Governor, Chief Minister, Speaker, Deputy Speaker, Federal and Provincial Ministers, Advisors to the Prime Minister or Chief Minister , or any other holder of public office will not visit the area of any local council to announce any development scheme or to canvass or campaign for any candidate or any political party.
- f. No Deputy Commissioner shall perform protocol duty with the Prime Minister, Chief Minister, Speaker, Deputy Speaker, Federal Ministers, State Ministers, Provincial Ministers, Advisors to the Prime Minister and Chief Minister or any person on their behalf till conclusion of the electoral process.
- g. Any holder of public officer, who is found to have violated any provision of election laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in law.

Note: The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays during the schedule period.

All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hour (08:00 a.m. to 04:00 pm) and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.
