NOTIFICATION

Islamabad, the 23rd December, 2015

No.F.25(1)/2015-LGE-KPK:— In exercise of the powers conferred upon it under Article 219 (d) of the Constitution of Pakistan, sub-section (1) of Section 75 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with sub-rule (10A) of rule 42 of Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules 2014 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby notifies the schedule to fill those reserved seats in Tehsil/Town Councils and District Council of the Khyber Pakhtunkhwa which have been secured by the different political parties during the Local Government Election held in 2015 but remained vacant due to exhaustion of the priority lists of their respective candidates of such political parties and in connection therewith, appoints the following dates of determination of qualification of prospective candidates of the such political parties:

(d)	Last date for filing of Appeals against decisions of the Returning Officers accepting/ rejecting the nomination papers	07.01.2016
(e)	Last date for deciding appeals by the Tribunal	09.01.2016
(f)	Last date for Withdrawal of candidature	11.01.2016
(g)	Publication of revised list of candidates	12.01.2016
(h)	Declaration of results by the Returning Officer on	14.01.2016

2. The authorized persons of those political parties whose priority list of candidates is

exhausted shall submit additional names of candidates under rule 42 (10A) *ibid*, on or before the filing of nomination papers by the candidates i.e. 31.12.2015 or in case, none of the candidate of such political parties has submitted nomination papers earlier but political party has secured number of general seats in District and Tehsil / Town Councils, they **shall also submit nomination papers** to the concerned Returning Officer in District Councils to fill those vacant reserved seats.

3. The Appellate Authority appointed vide this Commission's notification No.F.13(1)/2015-LGE-KPK dated the 29th April, 2015 shall be the same to hear and decide appeals against the decision of Returning Officer.
