Intellectual Property Tribunal, Karachi. The Learned Additional District & Session Judge, Karachi East shall be responsible for the trial and disposal of election petitions pertinent to the 2<sup>nd</sup> phase local government elections, 2022 held on 15<sup>th</sup> January, 2023, in respect of all categories of seats. In case, the specified/nominated judge is transferred, pending and fresh election petitions shall be tried and disposed of by his successors-in-office. Likewise, the same/appointed judge or their successors-in-office shall try and dispose of the election petitions emergent of succeeding bye-elections in future, if any.
