## NOTIFICATION

No. F.23(8)/2024-O/o-DD-Law: - In partial modification of the Commission's earlier notifications dated 26.04.2024 & 07.06.2024 and in pursuance of the provisions of Article 219(C) of the Constitution of Islamic Republic of Pakistan read with Section-140 of the Elections Act, 2017, the Election Commission of Pakistan in consultation with the Hon'ble Chief Justice, of Lahore High Court, Lahore for appointment of sitting judges as Election Tribunals and in pursuance of Section 140(2)(a) of the Act, appoints with immediate effect the following sitting & retired Judges to act as **Election Tribunals for General Election-2024** according to jurisdiction mentioned against their names for the trial and disposal of Election Petitions pertaining to National/ Provincial Assembly Constituencies for General Elections-2024 and subsequent bye-Elections:
