

No.F.16(1)/2023-LGE-KP (Vol-I):- In exercise of the powers conferred upon it under Articles 140A (2) of the Constitution of the Islamic Republic of Pakistan, sub-section (1) of Section 75(1) and Section-81(2) of the Khyber Pakhtunkhwa Local Government Act, 2013, read with Rule-52(6) of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021, and all other powers enabling it in that behalf, the Election Commission of Pakistan is pleased to fix **25th February, 2025 (Tuesday)** for the conduct of In-House Election to the seat of Chairman of Village Council Gidri, Tehsil & District Battagram and calls upon the Members/Electoral College to elect Chairman of the Council through open division.

The Returning Officer appointed *vide* this Commission Notification **No.F.7(2)/2024-LGE-KP** dated 21-02-2025 shall call meeting of the Council and inform all the Members of the concerned Council before election day, clearly intimating the date, time and place of the meeting. 
