## NOTIFICATION

Islamabad, the 10<sup>th</sup> October, 2017.

Subject:- SCHEDULE FOR BYE-ELECTIONS AGAINST VACANT SEATS OF GENERAL MEMBERS IN LOCAL COUNCILS OF DISTRICT KECH, BALOCHISTAN PROVINCE.

No.F.12(1)/2015-LGE-B (Vol-I) :- In exercise of powers conferred upon it under Article 140(A) of the Constitution of the Islamic Republic of Pakistan, sub-section (2-A) of Section 30 of the Balochistan Local Government Act, 2010 and read with sub-rule (1) & (2) of Rule 9 of the Balochistan Local Government (Election) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission hereby issues the schedule for election to fill the vacant seats of General Members in Local Councils and Wards of District Kech in Balochistan Province and calls upon the electors of respective Local Councils and Wards to elect their representatives as per following dates, and attached list of vacant seats:-

2. To ensure that elections to the Local Government are conducted in accordance with the provisions of Article 218(3) of the Constitution, the Election Commission of Pakistan directs that:

- a. All Executive Authorities in the Federation and in the Provinces shall not use State Resources in Local Government Bye-Elections calculated to influence the elections in favour of a particular candidate or a political party.

- b. If any person in government service misuses his official position in any manner in order to influence results of elections, he shall be liable to be proceeded against under Section 60 of the Balochistan Local Government Act, 2010.
- c. No transfers / postings of the civil servants shall be made after the issuance of Election Schedule of the Local Government Bye-Elections without prior approval of the Commission till the publication of election results.
- d. No leave of the civil servant will be granted after the issuance of Election Schedule of the Local Government Elections without prior approval of the Commission till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without the approval of the Hon'ble Commission.
- e. After the issuance of Election Schedule, the President, Prime Minister, Chairman/Deputy Chairman Senate, Speaker, Deputy Speaker, Federal Ministers, Ministers of State, Advisors to the Prime Minister another Public office holder shall neither openly nor in secret give any subscription or donation or make promises for giving such subscription or donation to any institution, nor shall inaugurate, commit to undertake or announce any development project therein for the advancement of the campaign of a candidate of his choice and thereby influence the results of elections.
- f. No Deputy Commissioner / District Coordination Officer shall perform protocol duty with the Prime Minister, Chief Minister, Speaker, Deputy Speaker, Federal Ministers, State Ministers, Provincial Ministers, Advisors to the Prime Minister and Chief Minister or any person on their behalf till conclusion of the electoral process.
- g. Any holder of public office, who is found to have violated any provision of election laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in law.

**Note:** *The offices of the Election Commission as well as the offices of District Returning Officers and Returning Officers shall remain open on all public holidays during the schedule period:*

All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hour (08:00 a.m. to 04:00 p.m.) and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.
