Subject: **SCHEDULE FOR THE CONDUCT OF BYE-ELECTION TO THE VACANT SEAT OF PEASANT/WORKER MEMBER MUNICIPAL COMMITTEE, KOTLI SATTIAN, DISTRICT RAWALPINDI.**

No.F.4(18)/2015-LGE(P)(Vol-V):— Pursuant to the provisions of Article 140A of the Constitution of Islamic Republic of Pakistan, sub-section (1) of Section 37 and sub-section (1) of Section 32 of the Punjab Local Government Act, 2013 read with Rule 50 of the Punjab Local Governments (Conduct of Elections) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby issues the schedule for conduct of **bye-election** to the seat of **Peasant/Worker Member Municipal Committee, Kotli Sattian, District Rawalpindi**, *fell vacant on the score of death of Ibadat Ahmad as notified by the Local Government & Community Development Department, Government of the Punjab, Lahore vide its Notification No.SOR(LG)47-08/2017 dated 30.08.2017 and ECP's Notification No.F.4(18)/2016-LGE(P)(Vol-IV) dated 13.09.2017*, calls upon the voters of concerned Municipal Committee to elect their representative to such seat and specifies in relation thereto, the following dates:

2. With a view to ensure that election to the Local Government is conducted in accordance with the provisions of Article 218(3) of the Constitution, the Election Commission of Pakistan directs that:

Contd...

- a. *All Executive Authorities in the Federation and in the Provinces shall not use State Resources in Local Government Bye-Election calculated to influence the election in favor of a particular candidate or a political party.*
- b. *If any person in government service misuses his official position in any manner in order to influence results of election, he shall be liable to be proceeded against under Section 60 of the Punjab Local Government Act, 2013.*
- c. *No transfers / postings of the civil servants shall be made after the issuance of Election Schedule of the Local Government / Bye-Election without prior approval of the Commission till the publication of election results.*
- d. *No leave of the civil servant will be granted after the issuance of Election Schedule of the Local Government Election without prior approval of the Commission till the publication of election results. In case leave has already been sanctioned, the officer will not relinquish his charge without the approval of the Hon'ble Commission.*
- e. *After the issuance of Election Schedule, the President, Prime Minister, Chairman/Deputy Chairman Senate, Speaker, Deputy Speaker, Federal Ministers, Ministers of State, Advisors to the Prime Minister another Public office holder shall neither openly nor in secret give any subscription or donation or make promises for giving such subscription or donation to any institution, nor shall inaugurate, commit to undertake or announce any development project therein for the advancement of the campaign of a candidate of his choice and thereby influence the results of election.*
- f. *No Deputy Commissioner/District Coordination Officer shall perform protocol duty with the Prime Minister, Chief Minister, Speaker, Deputy Speaker, Federal Ministers, State Ministers, Provincial Ministers, Advisors to the Prime Minister and Chief Minister or any person on their behalf till conclusion of the electoral process.*
- o. *Any holder of public office, who is found to have violated any provision of election laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in law.*
- p. *The poll shall be taken from **09:00 AM to 02:00 PM** without any break.*


***Note:** (i) The concerned offices of the Election Commission as well as the offices of District Returning Officer and Returning Officer shall remain open on all public holidays during the schedule period in case any activity is involved.*

(ii) All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.

(iii) *ECP's instructions issued from time to time for conduct of Local Government Elections, as far as practicable, shall be followed for conduct of election.*

No.F.4(18)/2015-LGE(P)(Vol-V).—In pursuance of the provisions of Article 218(3) of the Constitution of the Islamic Republic of Pakistan, sub-section (2) of Section 19 of the Punjab Local Government Act, 2013 read with Rule 78 of the Punjab Local Governments (Conduct of Elections) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission hereby authorizes the **District Returning Officer** and **Returning Officer** appointed for the conduct of bye-election to the seat of Peasant/Worker Member in Municipal Committee Kotli Sattian, District Rawalpindi of the Punjab Province, scheduled to be held on **6th November, 2017**, to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) with immediate effect till the announcement of official results.

2. The aforesaid officers shall exercise the powers of Magistrate First Class in respect of all offences under Chapter-V of the Punjab Local Government Act, 2013 except the offences under section 47 thereof. These offences shall be tried in a summary way in accordance with the provisions of the Code of Criminal Procedure, 1898 in terms of Section 60 of the Punjab Local Government Act, 2013.
