(h)	Last date for withdrawal of candidature	21-02-2018 (Between 0900 hours and 1600 hours)
(i)	Polling day	01-03-2018 (From 0900 hours to 1600 hours)
(j)	Place of Poll	Provincial Assembly Building, Lahore.
