الیکشن کمیشن نے چیف منسٹر خیبر پختو نخواہ جناب سہیل آفریدی کے حویلیاں جلسے کے خطاب کے دوران دیئے گئے بیان جس میں اُنہوں نے ضلعی انتظامیہ ، پولیس اور الیکشن میں تعینات عملہ کو دھمکا یا اور جلسے میں موجود پبلک اور عمو می طور پر عوام کو اُکسانے پر نوٹس لیا ہے ، اس موقع پر اُن کے ساتھ ایک مفرور مجر م بھی کھڑا تھا جس کی زوجہ الیکشن میں حصہ لے رہی ہیں۔ صوبے کے چیف ایگزیڑو کے اس غیر ذمہ دارانہ اور رویہ کی وجہ سے نہ صرف این اے 18 ہری پور میں پُر امن ضمنی انتخاب کا انعقاد مشکل ہو گیا ہے ، بلکہ ضلعی انتظامیہ ، پولیس اور الیکشن ڈیوٹی پر مامور عملہ اور ووٹروں کی جان کو بھی خطرہ لاحق ہوا ہے۔ کمیشن نے حالات کی نزاکت کوسامنے رکھتے ہوئے صوبائی الیکشن کمشنر خیبر پختو نخوا کو عمر دیا کہ وہ اس سلسلے میں فوری طور پر چیف سیکرٹری اور آئی جی سے میٹنگ کریں اور ضروری حفاظتی اقدامات کرنے کے بعد اپنی رپورٹ اکیشن کمیشن کو پیش کریں۔

الیکشن کمیشن نے معاملے کی سنگینی کو مدِ نظرر کھتے ہوئے چیف منسٹر خیبر پختو نخواہ سہیل آفریدی اور امید وار مساۃ شہر ناز عمرایوب کو الیکشنز ایکٹ 2017ء اور ضابطۂ اخلاق کی خلاف ورزی پر کل مور خہ 21 نومبر 2025 کو طلب کرتے ہوئے نوٹس جاری کر دیے ہیں۔

مزید رہے بھی فیصلہ کیا کہ فوری طور پر سیکرٹری وزارت داخلہ کو چہٹھی ارسال کی جائے کہ حلقہ میں وفاقی سیکورٹی اداروں کی مددسے فول پروف سیکورٹی انتظامات کیئے جائیں، تاکہ ڈسٹر کٹ ریٹر ننگ آفیسر ، ریٹر ننگ ، دیگر انتظابی اہلکاروں ، ووٹروں اور پبلک کے تحفظ کو بقینی بنا یاجا سیکے۔ اور Presiding Officers کی طرف اور الیکٹن کے بعد RO آفس کی طرف اُئی اور الیکٹن مٹیریل کی Movement کو تحفظ دیاجا سیکے۔

کمیشن نے بیہ بھی فیصلہ کیا کہ ضمنی انتخابات کے دوران کسی فرد، شخصیت پاپبلک آفس ہولڈر نے الیکشن کے پُرامن انعقاد میں مداخلت پاخلل ڈالنے کی کوشش کی تو اُلکے خلاف سخت قانونی کاروائی عمل میں لائے جائے گی۔صوبائی الیکشن کمشنر پنجاب کو بھی اسی طرح ہدایات جاری کردی گئی ہیں کہ اگر فیڈرل یاصوبائی حکومت کا کوئی بھی عہد پیدار ضابطہ اخلاق کی خلاف ورزی کرے یاضمنی الیکشن کو Influence کردی گئی ہیں کہ اگر فیڈرل یاصوبائی حکومت کا کوئی بھی عہد پیدار ضابطہ اخلاق کی خلاف ورزی کرے یاضمنی الیکشن کو گؤشش کرے تو آئین اور قانون کے مطابق سخت سے سخت کاروائی کی جائے۔

VIOLATION OF CODE OF CONDUCT BY CHIEF MINISTER KPK.

Through media and our monitoring unit reports, it was informed that the Chief Minister, Khyber Pakhtunkhwa participated in a public meeting / Jalsa as a part of the election campaign of Mst. Shehar Naz Omar Ayub Khan in NA-18 Haripur, Tehsil Havelian yesterday evening and delivered a provocative speech against public functionaries including district management, police and election officials (DRO/RO) regarding the upcoming bye-election. The speech is in direct contravention of Section 170 of the Elections Act, 2017 and Clauses 10 & 18 of the Code of Conduct issued by the Election Commission. These clauses categorically forbid Chief Ministers from taking part in any election campaign and further prohibits incitement of the public to violence and / or intimidation of public officials and voters by use of such language.

- 2. The Provincial Election Commissioner, KP has already been instructed to hold a meeting with you and Inspector General of Police, KP along with other relevant officers today at 11:30 a.m. to assess the situation created as a result of this matter.
- 3. It is requested that the meeting must be personally attended by the Head of Provincial Administration (Chief Secretary) as well as the Head of Police (IG, KP). A detailed report of the proceedings and recommendations shall be forwarded by the PEC, KP to the Hon'ble Election Commission for further action.

Regrettably, he used offensive language, which amounts to harassing and unduly influencing them which may prevent them from effective performance of their duties (Copy of transcript of speech is enclosed). The Commission is of the view that said act of the Chief Executive of the Province has created live threats to the election officials and specially the voters. Further, a fugitive was also accompanying the Chief Minister and the concerned authorities have not taken any action against him.

You are, therefore, requested to take immediate notice of this situation and deploy Civil Armed Forces/Pakistan Army to allow the peaceful conduct of polling on 23<sup>rd</sup> November, 2025 in the constituency and also to take other appropriate measures to protect the lives of Election Officials, voters and public at large during the said elections.
