Subject:- **MAGISTERIAL POWERS TO DISTRICT RETURNING OFFICER AND RETURNING OFFICER APPOINTED FOR THE CONDUCT OF LOCAL GOVERNMENT ELECTION TO THE VACANT SEAT OF CHAIRMAN THESIL COUNCIL JAMRUD, DISTRICT KHYBER IN KHYBER PAKHTUNKHWA PROVINCE.**

No.F.8(2)/2024-LGE-KP:— In pursuance of the provisions of Article 140(2) and 218 of the Constitution of the Islamic Republic of Pakistan, Sections-06 & 193(a)(b) of Elections Act, 2017 and Section-101 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule-2 of the Khyber Pakhtunkhwa Local Councils (Conduct of Election) Rules, 2021, the Election Commission hereby authorizes the District Returning Officer and Returning Officer appointed for the conduct of Local Government Election to the vacant seat of Chairman, Tehsil Council Jamrud, District Khyber in Khyber Pakhtunkhwa, whereby polling will be held on **25<sup>th</sup> September, 2024** to exercise the powers of Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) with immediate effect till the announcement of official results.

2. The aforesaid officers shall exercise the powers of Magistrate First Class in respect of all offences under Section-193(a)(b) of the Elections Act, 2017 and Chapter-XIV of the Khyber Pakhtunkhwa Local Government Act, 2013, whereby all such offences shall be tried summarily under the Provisions of the Code of Criminal Procedure, 1898 (Act No. V 1898).
