



Subject: **SCHEDULE FOR THE CONDUCT OF LOCAL GOVERNMENT FRESH ELECTIONS TO THE SEATS OF CHAIRMAN & VICE CHAIRMAN UC-91, DISTRICT COUNCIL, SIALKOT.**

No.F.4(17)/2015-LGE(P)(Vol-XXXI):—Pursuant to the Judgment dated 31.05.2018 passed by August Supreme Court of Pakistan in Civil Petition No.4682/2017 titled “Ejaz Ahmed Sandhu vs. ECP and others” provisions of Article 140A of the Constitution of Islamic Republic of Pakistan Rule 11 of the Punjab Local Governments (Conduct of Elections) Rules, 2013 and all other powers enabling it in this behalf, Election Commission of Pakistan hereby issues the Schedule for filling up the Direct Vacant Seats of **Chairman & Vice Chairman, UC-91, District Council, Sialkot** and calls upon the voters of concerned constituency to elect their representatives and specifies in relation thereto, the following dates:

2. With a view to ensure that election to the Local Government is conducted in accordance with the provisions of Article 218(3) of the Constitution, the Election Commission of Pakistan directs that:

- a. *All Executive Authorities in the Federation and in the Provinces shall not use State Resources in Local Government Bye-Election calculated to influence the election in favor of a particular candidate or a political party.*
- b. *If any person in government service misuses his official position in any manner in order to influence results of election, he shall be liable to be proceeded against under Section 60 of the Punjab Local Government Act, 2013.*

- c. Any holder of public office, who is found to have violated any provision of election laws or the instructions issued by the Election Commission, shall be proceeded against as mandated in law.
- d. The poll shall be taken from **08:00 AM to 04:00 PM** without any break.

Note: (i) The concerned offices of the Election Commission as well as the offices of District Returning Officer and Returning Officer shall remain open on all public holidays during the schedule period in case any activity is involved.

(ii) All electoral activities mentioned in the aforesaid schedule shall be undertaken during office hours and the said timing will also be followed on public holidays fixed for any electoral activity of the schedule.

(iii) ECP's instructions issued from time to time for conduct of Local Government Elections, as far as practicable, shall be followed for conduct of election.

No.F.4(18)/2015-LGE(P)(Vol-VII).—In pursuance of the provisions of Article 218(3) of the Constitution of the Islamic Republic of Pakistan, sub-section (2) of Section 19 of the Punjab Local Government Act, 2013 read with Rule 78 of the Punjab Local Governments (Conduct of Elections) Rules, 2013 and all other powers enabling it in that behalf, the Election Commission hereby authorizes the **District Returning Officer** and **Returning Officer** appointed for the conduct of Local Government fresh elections to the direct vacant seats of **Chairman & Vice Chairman, UC-91, District Council, Sialkot**, scheduled to be held on **2nd December, 2018** and **Re-Poll** for the seat of **General Member, Ward No.3, UC-91, District Council, Sialkot** scheduled to be held on **18.11.2018** to exercise the powers of the Magistrate First Class under the Code of Criminal Procedure, 1898 (Act No. V of 1898) with immediate effect till the announcement of official results.
