No.F.32(2)/2018-LGE-KPK(2).- In exercise of the powers conferred upon it under Article 140A (2) of the Constitution of the Islamic Republic of Pakistan, Sections-75 & 86 of the Khyber Pakhtunkhwa Local Government Act, 2013 read with Rule-9 of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2014 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby appoints the following District Returning Officers, Returning Officers and Assistant Returning Officers for the conduct of Local Government 8<sup>th</sup> Bye-Election to fill in different categories of vacant seats i.e. General, Woman, Peasants/ Workers, Youth and Minority in various Local Councils of the Khyber Pakhtunkhwa Province, as per jurisdiction assigned hereunder:-


