No.F.4(16B)/2016-LGE(P)(Vol-VI).---In pursuance of the Order dated 06.12.2018 passed by the Hon'ble Election Commission in Case No.24(207)/2016-Law, provisions of Article 140A of the Constitution of Islamic Republic of Pakistan read with the provisions of Section 227 of Elections Act, 2017 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby disqualifies Mr. Mukhtiar Ahmad Rehmani S/o Niaz Ahmad from the seat of Peasant/Worker Member, Municipal Committee, Kot Addu, District Muzaffargarh by recalling the Notification No.F.4(16B)/2016-LGE(P) dated 30.11.2016 to his extent.
