Islamabad the 20<sup>th</sup> March, 2019

No.F.17(1)/2019-Cord.- Pursuant to the Order dated 13.03.2019 passed by the Hon'ble Election Commission of Pakistan in case No.F.20(2)/2018-Law titled "Mian Muhammad Akhtar Hayat Vs. Mian Tariq Mehmood and others", the Election Commission hereby disqualifies Mian Tariq Mehmood as Member, Provincial Assembly of Pakistan from Constituency No.PP-113 Gujrat-VI against General Elections, 2013. Consequently, the Notification No.F.2(40)/2013-Cord, dated 22.05.2013 and Notification No. F.2(41)/2013-Cord, dated 05.06.2013 to the extent of declaring Mian Tariq Mehmood as Member Provincial Assembly of Punjab shall stand rescinded abinitio.

2. As a result, Mian Tariq Mehmood shall be deemed to be never declared elected Member of the Provincial Assembly of Punjab from Constituency No.PP-113 Gujrat-VI after General Elections 2013.
