NOTIFICATION

No. F.1(1)/2019-Confid (2).— WHEREAS, sub-section (1) of section 137 of the Elections Act, 2017 read with sub-rule (1) of rule 137 of the Election Rules, 2017 thereof, provides that every Member of an Assembly and Senate shall submit to the Commission, on or before 31st December each year, a copy of his statement of assets and liabilities including assets and liabilities of his spouse and dependent children as on the preceding thirtieth day of June on Form B.

AND WHEREAS, in compliance of sub-section (3) of section 137 of the Act *ibid*, the following Members of **Senate, National Assembly, Provincial Assemblies, Punjab, Sindh, KPK and Balochistan** were ordered to cease to function as Members of the said Assemblies and *vide* Notifications of even number, dated the 16th January, 2020:-
