No.F.1(3)/2020-LGE-KP(Vol-III):- WHEREAS, the Election Commission of Pakistan under Article 222(b) of the Constitution of the Islamic Republic of Pakistan and Section-221 of the Elections Act,2017 read with Section-6 of the Khyber Pakhtunkhwa Local Government Act, 2013 is charged with the duty to Delimit the Constituencies of the Local Government Institutions.

WHEREAS, the Election Commission of Pakistan has issued schedule to carry out Delimitation of Village/ Neighbourhood Councils in Districts Abbottabad, Bannu, D.I.Khan, Kohat, Mardan & Swat of Khyber Pakhtunkhwa province vide Notification bearing No.F.1(3)/2020-LGE-KP(Vol-III) dated 21.12.2020 whereupon proceedings will be started by the Delimitation Committees as notified for each District.

AND WHEREAS, Delimitation of Village/ Neighbourhood Councils is required to be carried out giving due regard to the existing boundaries of administrative units such as District, Tehsil, Patwar Circles etc and change in limits of these units while proceedings of Delimitation are under ways shall hamper the smooth proceedings.

Article 218 (3) of the Constitution of the Islamic Republic of Pakistan read with Section 219 (6) of the Elections Act, 2017 and all other powers enabling it in that behalf, the Election Commission of Pakistan is pleased to direct that boundaries of existing administrative units shall stand ceased forthwith and no change in the boundaries of aforementioned administrative units shall be made till the culmination of Delimitation process in above referred Districts of Khyber Pakhtunkhwa Province.
