
NOTIFICATION

No.F.8(4)/2021-Cord(1).—In exercise of powers under section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the District Returning Officer and Returning Officer appointed for the conduct of Bye-election in constituency No.PS-70 Badin-I scheduled to be held on **20.05.2021** to exercise the powers of the Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act V of 1898); with immediate effect and until the consolidation and announcement of official results.
