No. F.6(1)/2021-LGE(C).--- In exercise of powers conferred upon it under Article 140-A (2) & 219(d) of the Constitution of Islamic Republic of Pakistan, Sections 50, 51 & 224 of the Elections Act, 2017 and provisions of sub-section (4) of Section 58 of the Cantonments (Amendment) Ordinance, 2015 read with Rule 13 of the Cantonments Local Government (Election) Rules, 2015, the Election Commission of Pakistan hereby appoints the following officers as District Returning Officers, Returning Officers and Assistant Returning Officers for the purpose of conducting Local Bodies Elections in respect of **42** Cantonment Boards from the wards in the Cantonments mentioned there-against:
