No.F.21(1)/2021-LGE(C).— In pursuance of the provisions of sub-section (1) of Section-58 of the Cantonments Ordinance, 2002 (as amended from time to time) read with Rule-77 of the Cantonments Local Government (Election) Rules, 2015 and all other powers enabling it in that behalf, the Election Commission of Pakistan hereby issues the following Programme for Election to fill the Special Interest Seats (reserved seats) in Cantonment Boards and calls upon the directly elected members of the Cantonment Boards to elect members against the attached list of such seats in Cantonment Boards as provided by the Military Lands and Cantonments Department:

- All electoral activities mentioned in the aforesaid programme except for those for which time is fixed in the Rules, shall be undertaken during office hours (08:00 A.M. to 05:00 P.M.) and the said timing will also be followed on public holidays fixed for any electoral activity of the programme.
- Polling Hours shall be from 08:00 am to 4:00 pm.**
