NOTIFICATION

F. 18(1)/2021-LGE-C: The Election Commission of Pakistan issued Election Programme for conduct of Local Government Elections in Cantonment Boards on 09.07.2021 and Muhammad Iqbal, Tehsildar was appointed as Assistant Returning Officer in respect of Ward No. 6 to 10 of Lahore Cantonment Board for the said elections, held on 12.09.2021.

2. During the proceedings for conduct of said elections, it was reported by the Returning Officer, Ward No. 6 to 10, Lahore Cantonment Board and endorsed by the District Returning Officer, Lahore Cantonment Board that the above-said Assistant Returning Officer is not performing election duties properly and efficiently.

3. The Election Commission thereupon vide its order dated 06.09.2021, suspended the above-said ARO till the conclusion of regular inquiry conducted against his misconduct under Section-55 of the Elections Act, 2017. However, the Election Commission while considering the request of the incumbent dated 14.10.2021 and taking a lenient view, has been pleased to reinstate Mr. Muhammad Iqbal, Tehsildar, Lahore Cantonment with the directions to be careful in future.
