No.F.16(1)/2021-LGE-KP(Vol-I):- In exercise of the powers conferred upon it under Articles 140A (2) and 219(d) of the Constitution of the Islamic Republic of Pakistan read with Sections 58 and 219(3) of the Elections Act, 2017, sub-section (1) of Section 75 & Section-86 of the Khyber Pakhtunkhwa Local Government Act, 2013, Rule-77(b) of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021 and all other powers enabling it in that behalf; the Election Commission of Pakistan hereby fixes **14th April, 2022 (Thursday)** as the date for the conduct of election to the seats of Chairman of Local Councils in districts, Peshawar, Nowshera, Charsadda, Khyber, Mardan, Swabi, Kohat, Hangu, Bannu, D.I.Khan, Tank, Haripur, Buner and Bajaur, and calls upon the Members/ Electoral College of following councils to elect Chairman of their respective Councils;

2. The Election shall be conducted in accordance with the procedure provided in Chapter-VIIA of the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021 and as per instructions of the Commission.

3. The Returning Officer appointed vide this Commission Notification No.7(2)/2021-LGE-KP(Vol-IV), Dated 31-03-2022 shall call meeting of such Village Council or Neighbourhood Council under their respective jurisdiction and informed all the Returned Candidates of the concurred Council before election day, clearly intimating the date, place and time of the meeting. The date of the meeting shall be 14th April, 2022 i.e. Election Day.

4. The nomination Form-XXVI attached with the Khyber Pakhtunkhwa Local Councils (Conduct of Elections) Rules, 2021 shall be used for filling of nomination papers by the contesting candidates.

5. The Returning Officer shall keep record of the proceedings.

6. All the Activates of election i.e. Filling of Nomination, Scrutiny of Nomination Papers and Withdrawal of candidature shall be completed on the same day as fixed for the election i.e. 14th April, 2022.

7. Election Hours will be observed from 02:00 PM to 05:00 PM.

Election of Chairman of Neighborhood/Village Councils where General Members have been elected un-opposed

KPK LGE, 2021 (1st Phase)

Appointment of Returning Officers:

Election Commission, shall appoint Returning Officers (RO), for such VC/NC where General Members have been elected un-opposed and where Chairman of the council has not been determined. The Returning Officers will proceed to conduct election of Chairman, in their respective Councils in the following manner:

(A) First Meeting of the Council:

- i. RO to convene and preside over the first meeting Neighbourhood/Village Council.
- ii. RO should send a notice in writing to all members of the Council indicating therein the date, time and venue of the first meeting of the Council.
- iii. In the first meeting no other business will be transacted by the Council until election of Chairman is completed.

(B) Nominations:

- i. Any member of the Council may propose or second name of any General Member of that Council for the seat of Chairman.
- ii. A nomination paper on (Form XXVI) will be filed by the contesting candidates with RO. The nomination Form shall have signatures of the proposer and seconder as well as that of the candidate nominated.
- iii. A candidate may be proposed by more than one nomination paper but a member cannot propose or second more than one candidate.

- iv. Every nomination paper shall be filed with RO of the relevant Local Council by 1:00 PM on the day fixed for the Election.
- v. The Nomination Paper shall be delivered by the candidate or his proposer or seconder.

(C) Scrutiny:

- i. RO should scrutinize nomination papers received by him/her in the presence of candidates and their proposers and seconders as may be present.
- ii. RO may reject a nomination paper if he/she is satisfied that:
 - a. The candidate is not a member of that Local Council;
 - b. the signature of the candidate or proposer or seconder is not genuine; or
 - c. A proposer or seconder has subscribed to nomination of more than one candidate. However rejection of a nomination paper of a candidate shall not invalidate other nomination papers filed by the same candidate.
- iii. RO should endorse his/her decision on every nomination paper.
- iv. The decision of RO shall be final.

(D) Withdrawal of candidature:

A candidate may withdraw his/her candidature at any time before the election takes place.

(E) Election of Chairman:

- i. The RO shall read out to the Local Council, the names of contesting candidates in the order in which nomination papers are received and proceed to effect the election by an **open division** in the following manner-
 - a. The RO will ask the members to proceed to a place specified in the room/hall, where an officer will be

deputed to ascertain the support of each member for the candidate of his/her choice in a Register to be supplied by the PEC (Specimen of Register is given at the end).

- b. Each member will enter name of the candidate of his/her choice in the relevant column in the Register, sign it and put his/her thumb impression before leaving the meeting room/hall.
- c. A member who is unable to enter name of candidate of his/her choice, due to any reason, may seek assistance of the officer maintaining the Register.
- d. No member who has recorded his/her support will be allowed to re-enter the meeting room/ hall, unless all members present have recorded their support.

ii. A Chairman has to secure support of majority of the members of the Council.

- iii. If there remain only one contesting candidate after scrutiny of nomination papers, and he secures the support of the Majority of the members of the Council, the Returning officer shall declare him to be the Chairman of the Village/Neighbourhood Council.
- iv. If there is only one candidate and he/she is not able to secure support of the majority of the members of the Council, all proceedings shall commence again for the election on next day of election.
- v. If there are two or more contesting candidates, the candidate who secures support of the majority of the members of Council shall be declared Chairman of the Council
- vi. If no candidate secures majority of the members of the council in the first meeting, a second meeting of the council shall be held on next day and election will be held between the top two candidates of first round. The candidate who then supported by majority of the members of the council shall be declared as Chairman of



the Council.

- vii. In case, only one general member is available in the council, he shall be declared as chairman. No need of register. RO shall write in the 5th Column of format A, **"elected as sole General member"**
- viii. In case, two general members are returned in entire council, the Returning officer shall draw a lot and the chairman shall be the candidate on whom the lot falls. No Need of Register. RO shall record the proceeding of lot and write in the 5th column of format A, **"through Lot"**
- ix. In case three general members are returned in the council as unopposed and all reserved seats are vacant, then chairman will be decided later on after conduct of bye-elections on the vacant seats.
- x. If two or more candidates are supported by an equal number of members, the Returning Officer shall draw a lot in respect of such candidates and the candidate on whom the lot falls shall be the Chairman of the Council.
- xi. The lot shall be drawn in presence of the contesting candidates and their election agents as may be present.
- xii. If no candidates secure majority of the members in the first two meeting, further two meeting with interval of one week in between, shall be held to determine the Chairman of the council as per above procedure.
- xiii. The RO shall declare name of the member commanding the confidence of the majority of the members of the council having been elected as Chairman of the Council and administer him /her Oath of Office in the manner prescribed in schedule-II of the Khyber Pakhtunkhwa Local Councils(Conduct of Elections) Rules,2021.
- xiv. On the conclusion of the election of chairman of the Council the RO shall prepare the result of election to the seat of Chairman of the council on the format-A and shall immediately forward the same to the Provincial Election



Commissioner through District Election Commissioner concerned along with attested copy of the relevant pages of the Register provided for maintaining record of the proceedings of recording support of the candidates for the seat of Chairman.

- xv. The PEC shall forward the consolidated result of councils in soft as well as in hard form on format-B to the Commission.
