No. F.3(1)/2022-LGE(S):- In exercise of power conferred upon it under Article 140A and 219 (d) of the constitution of Islamic Republic of Pakistan, Section 224 of the Elections Act, 2017 and Section 40 of the Sindh Local Government Act, 2013 read with Rule 11 of the Sindh Local Councils (Election) Rules, 2015, and all other powers enabling it in that behalf, the Election Commission of Pakistan is hereby appoint the officers as District Returning Officers, Returning Officers and Assistant Returning Officers, as under, to fill up the category of seats of Member District Councils from the Union Councils, Chairmen / Vice-Chairmen and members in each Union Council / Union Committee and members from the wards of each Municipal Committee and Town Committee in various local councils of Sindh Province.
