### **NOTIFICATION**


Islamabad, the 27<sup>th</sup> June, 2022

No.F.8(5)/2022-Cord(1).—In exercise of powers under section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the District Returning Officers and Returning Officers appointed for the conduct of Bye-elections in (20) Constituencies of Provincial Assembly of Punjab scheduled to be held on **17<sup>th</sup> July, 2022** to exercise the powers of the Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act V of 1898); with immediate effect and until the consolidation and announcement of official results in following Constituencies.



No.F.8(5)/2022-Cord(2).- In exercise of powers under section 193 of the Elections Act, 2017 (Act No. XXXIII of 2017), the Election Commission hereby authorizes the Presiding Officers appointed for each Polling Station of following constituencies of Provincial Assembly of Punjab, to exercise the powers of a Magistrate of the First Class under the Code of Criminal Procedure, 1898 (Act No.V of 1898) from 16<sup>th</sup> July, 2022 to 18<sup>th</sup> July, 2022, in respect of the offences punishable under section 169 and section 171 punishable under Section 174 of Elections Act, 2017 (Act No. XXXIII of 2017) and may take cognizance of any such offence under Section 190 of the Code of Criminal procedure and shall try it summarily under Chapter XX of the Code.


