## NOTIFICATION

**No. F. 20(1)/2022-Law** :- In pursuance of Section 140 (1)(b) of the Elections Act, 2017, read with section 47(1) of the 'Sindh Local Government Act, 2013 and rule 63(1) of the 'Sindh Local Government (Election) Rules, 2015', Election Commission of Pakistan, in consultation with the Hon'ble Chief Justice of the High Court of Sindh, Karachi, is pleased to appoint the following District & Sessions Judges/ Additional District & Sessions Judges to act as election tribunals for the area specified against their names for the trial and disposal of election petitions pertinent to the 1<sup>st</sup> phase local government elections, 2022 held on 26<sup>th</sup> June, 2022, in respect of all categories of seats. In case, any of the specified/nominated judges is transferred, pending and fresh election petitions shall be tried and disposed of by his successors-in-office. Likewise, the same/appointed judges or their successors-in-office shall try and dispose of the election petitions emergent of succeeding bye-elections in future, if any:-
